Whereas, the Jammu and Kashmir Services Selection Board vide communication No.SSB/ Secy/Sel/1106-13 dated 24.01.2017 & No. SSB/Sel/Secy/2017/3407-8 dated 22.03.2017 recommended selection of 13 candidates for the posts of Jr. Scale Stenographer(Divisional Cadre Jammu) advertised vide Advertisement Notice No.05 of 2015 dated 01.09.2015; and

Whereas, the formal appointment orders were issued by Finance Department vide Government Order No. 46-FD of 2017 dated 03.03.2017 & Government Order No. 158-F of 2017 dated 18.05.2017, in respect of the selected candidates with the directions to report to Commercial Taxes Department; and


