Whereas, the Finance Department vide Communication Nos: Et/Estt/154/2012 dated 26-03-2013, No. Et/Estt/296/2006 dated 04-10-2017, No. Et/Estt/128/2004 dated 28-07-2006 referred the posts of Jr. Assistant (Divisional Cadre Kashmir) in various categories of J&K Excise and Commercial Taxes (Subordinate) Service to J&K Service Selection Board for selection of suitable candidates; and

02- Whereas, on the recommendations of the Service Selection Board, Finance Department has issued appointment orders vide Government Order No. 80-F of 2016 dated 16-03-2016 and Government Order No. 17-F of 2016 dated 19-01-2016 in respect of selected candidates; and

03- Whereas, the Jammu and Kashmir Services Selection Board vide communication No. SSB/Secy/Sel/2018/9602-08 dated 04-09-2018 forwarded selection list of 10 candidates (RBA =01, SC =05, ST =04) (backlog posts) out of which the recommendations in favour of 02 candidates have been withheld.

04- Now, as recommended by Services Selection Board, sanction is hereby accorded to the temporary appointment of following 08 candidates as

Junior Assistant (Divisional Cadre Kashmir) in the pay Band pre revised 5200-20200 with Grade Pay of Rs. 1900/- (Now revised to 2400 as per SRO-333) in the J&K Excise and Commercial Taxes (Subordinate) Service with immediate effect.

The appointment of the above said candidates shall be subject to fulfillment of the following conditions:-

- A) **The appointment including pay, service etc shall be governed in terms of J&K Special Recruitment Rules, 2015 (SRO-202 dated 30-06-2015).**
- B) The appointees shall report to the **Commissioner, Commercial Taxes** within a period of 21 days from the date of issuance of the order.
- C) In case of failure of appointee to join within the stipulated period, his /her appointment shall be deemed to have been cancelled ab-initio without any further notice.
- D) The appointees shall be allowed to join only on production of the following certificates in original:-
 1. Academic/Technical Qualification Certificates.
 2. Matriculation/Date of Birth Certificate.
 3. Health Certificate issued by Chief Medical Officer.
 4. Permanent Resident Certificate issued by the Competent Authority.
 5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
 6. Reserved Category Certificate (in case of candidates belonging to reserved category).

6) The appointment of the candidates as Jr. Assistant (Divisional Cadre Kashmir) shall further be subject to the following conditions:-

- i. The appointees shall give an undertaking duly attested by the 1st Class Magistrate in the shape of an affidavit to the effect that in case adverse report about their character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidates shall have no right to claim their appointment as Jr. Assistant and their appointment as such shall be deemed to have been cancelled ab-initio.
- ii. If on verification, the certificate(s) produced by the appointees are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- iii. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.
- iv. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.


