Whereas, the Finance Department vide communication No.ET/Estt/154/2012 dated 11-08-2015 referred 13 vacancies of Drivers (OM=05, RBA=03, SC=02,ST=02 and ALC=01) Divisional Cadre Jammu, of J&K Excise & State Taxes (Subordinate) Service under Fast Track Recruitment to J&K Service Selection Board for selection of eligible candidates and the Services Selection Board vide communication No. SSB/Secy/Sel/2018/2048-54 dated 19-02-2018 has forwarded select list of 13 candidates for the post of Driver (Divisional Cadre Jammu) advertised vide Item No. 255, Notice No.05 of 2015 dated 01-09-2015 and withheld recommendations in favour of 12 candidates for want of valid driving license, Date of Birth & valid category certificates;

02. Whereas, Service Selection Board vide various communications released the recommendation in favour of 08 Driver (State Cadre/Divisional Cadre Jammu) and the Finance Department vide Government Order No. 194-FD of 2018 dated 03.04.2018, Government Order No. 212-FD of 2018 dated 16.04.2018, Government Order No.280-FD of 2018 dated 06.06.2018 and Government Order No.334-FD of 2018 dated 27.07.2018 issued appointment orders in favour of the selectees; and

03. Whereas, Service Selection Board vide Order No.502-SSB of 2018 dated 31.12.2018 cancelled/withdrew the candidature of 04 candidates namely

Darshan Singh figuring at S.No.03 under OM/RBA, Naseer Ahmad Khan S.No.04/OM/RBA, Mohan Lal S.No. 01/SC/Wait and Pankaj Sharma 01/ALC/Wait ab-initio and the department was requested to operate the waiting list.

04. Whereas, the Services Selection Board vide communication No. SSB/Sel/Secy/2019/771-73 dated 24.01.2019 released the recommendation in favour of Kulvinder Singh figuring at S. No. 01/OM/wait and Sanjeshwar Singh figuring at S.No. 02/OM/Wait.

05. Now, therefore, in terms of J&K Special Recruitment Rules, 2015 (SRO-202 dated 30-06-2015) and as recommended by the J&K Service Selection Board, sanction is hereby accorded to the temporary appointment in favour of following (02) candidates as Driver (Divisional Cadre Jammu) in the pay Band of Rs.5200-20200 with grade pay of Rs.1900/- (pre-revised) in the J&K Excise and State Taxes (Subordinate) Service with immediate effect by way of operating waiting list:-

06. The appointment shall be subject to fulfillment of following conditions:-

- A) The appointment including pay, service etc shall be governed in terms of J&K Special Recruitment Rules, 2015(SRO-202 dated 30-06-2015).
- B) The appointee shall report to the **Excise Commissioner, J&K** within a period of 21 days from the date of issue of the order.
- C) In case of failure of appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled without any further notice.
- D) The appointees shall be allowed to join only on production of the following certificates in original:-
 1. Academic/Technical Qualification Certificates.
 2. Matriculation/Date of Birth Certificate.
 3. Health Certificate issued by Chief Medical Officer.
 4. Permanent Resident Certificate issued by the Competent Authority.

5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
 6. Valid Driving License.
 7. Relevant Category certificates (in case of candidates belonging to reserved categories).
- E) The appointment of the candidates as Driver shall further be subject to the following conditions:-
- i. The appointees shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about their character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim their appointment as Driver and their appointment as such shall be deemed to have been cancelled ab-initio.
 - ii. If on verification, the certificate(s) produced by the appointees are proved to be fake or forged, the appointment shall be cancelled ab-initio.
 - iii. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.
 - iv. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.


