Sanction is hereby accorded to the following amendments in the Jammu and Kashmir Book of Financial Powers:-

In the Book of Financial Powers in Chapter 5.9 against S.No. 123-A(1), the column 'Extent' shall be recast as under:

The payment shall be subject to the condition that the relief, granted by the Government under the Workman's Compensation Act, shall be adjusted while making payment of the Ex-gratia relief.</p> <p><u>B.Domestic Animals</u></p> <p>i. Cow ,bull, horse=Rs 20,000</p> <p>ii.Sheep/Goat=Rs 5,000.</p>


