"The Contract Committee shall be headed by the Development Commissioner (Works), PW(R&B), J&K and Development Commissioner (Power), J&K for grant of administrative approval for projects/works in the following non-engineering departments:

- The financial limit prescribed for such Contract Committees unchanged i.e. that remain of Development Commissioner.
- The Contract Committees shall appraise the proposals and perform the role of a Departmental Contract Committee.
- An officer of the level of Special Secretary/Additional Secretary iii. of the said Department will also be a part of the Contract Committee."


