- The arrears on account of additional instalment of DA from July, 2019 i) to November, 2019 shall be paid in cash in December, 2019 and shall form part of the monthly salary from December, 2019 onwards.
- The payment of Dearness Allowance involving a fraction of 50 paisa ii) and above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.
