**Subject: Release of Funds to Divisional Commissioner Jammu/Kashmir and each District Development Commissioner under Capex Budget in connection with "Back to Village" Programme.**

Sanction is hereby accorded to the authorization of Rs 121.00 crore (Rupees one hundred twenty one crore only) through BEAMS with Rs 5.00 crore each to Divisional Commissioner Jammu/Divisional Commissioner Kashmir and Rs 1.00 crore to Divisional Commissioner Ladakh and Rs 5.00 crore each to 22 District Development Commissioners for undertaking works identified in respective **"Panchayat Halqas"** of their district in respect of demands raised during **"Back to Village"** Programme held from 20<sup>th</sup> June to 27<sup>th</sup> June, 2019.

The Funds so authorized to Divisional Commissioner Ladakh shall be operated amounting to Rs 0.50 lakhs (Rupees fifty lakhs only) each through District Development Commissioners Leh and kargil respectively.

The District Development Commissioner of each district shall identify high priority works with due impact and high visibility to be implemented as part of **"Back to Village"** Programme in convergence with other schemes on the basis of reports finalized by officers during their visit.

The list of identified works shall be furnished by Divisional Commissioner Jammu/Kashmir and each District Development Commissioner to the Finance Department within a period of 15 days and only such works shall be taken which can be completed during current financial year, 2019-20.


