Sanction is hereby accorded to the authorization of Rs. 25.00 Crore (Rupees twenty five crore only) through BEAMS @ Rs 5.00 crore each to the District Development Commissioners of the following Districts for undertaking works identified in respective **"Panchayat Halqas"** in respect of demands raised during **"Back to Village"** Programme held from 20<sup>th</sup> June to 27<sup>th</sup> June, 2019:-

1. Baramulla
2. Kupwara
3. Rajouri
4. Anantnag
5. Bandipora

The District Development Commissioner of each district shall identify high priority works with high impact and visibility to be implemented as part of **"Back to Village"** Programme in convergence with other schemes on the basis of reports finalized by officers during their visit.

The list of identified works shall be furnished by each District Development Commissioner to the Finance Department within a period of 15 days and only such works shall be taken which can be completed during current financial year, 2019-20.

The Planning, Development and Monitoring Division shall evaluate 5% of work selected on random basis within two months from the issuance of this order.

The funds shall be utilized after following due tendering procedure and observing all the required codal formalities.


