Subject: Selection list of the candidates for the post of Sub-Inspector, Finance Department (Divisional Cadre Jammu)- recommendation released.

Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 11.08.2015 referred seventy four (74) posts (OM=21, RBA=25, SC=10, ST=12, OSC=02 & ALC=04) of Sub-Inspector (Divisional Cadre Jammu) of the J&K Excise and State Taxes (Subordinate) Service to J&K Services Selection Board for selection of suitable candidates; and

2. Whereas, the Jammu & Kashmir Services Selection Board vide communication No. SSB/Secy/Sel/2019/155-61 dated 08-01-2019 forwarded a select list of seventy four (74) candidates along with the waiting list for the post of Sub-Inspector (Divisional Cadre Jammu) advertised vide item No. 254 (05 of 2015) indicating therein that recommendation in favour of eighteen (18) Sub-Inspector have been with held for want of requisite documents; and

3. Whereas, the Finance Department vide Government Order No.65-FD of 2019 dated 29.01.2019 issued appointment order in favour of 56 selectees; and

4. Whereas, the Jammu & Kashmir Services Selection Board vide different communications subsequently from time to time released the recommendations in favour of 16 candidates and Finance Department vide Government Order No. 341-FD of 2019 dated 24.04.2019 and Government Order No. 365-FD of 2019 dated 13.06.2019 issued appointment orders in favour of Sixteen (16) Sub-Inspectors; and

5. Whereas, the J&K Services Selection Board vide No. SSB/Sel/Secy/J/19/4856-58 dated 18.09.2019 has now released the recommendation in favour of Younis Latief figuring at S.No. 25/RBA/HCL subject to acceptability of disability by the indenting Department; and

6. Whereas, the selectee was asked to produce the disability certificate duly attested by the competent authority and he has produced the copy of the disability certificate issued by District Medical Board Doda in which the extent of his disability has been certified to be 45 % (in Right Lower Limb) ; and

7. Now, as recommended by the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of Younis Latief S/o Mohd Latief R/o Pora Bala Bhallesa Doda as Sub-Inspector (Divisional Cadre Jammu) in the pay Level-4 (25500-81100) (S.No. 25/RBA/HCL category) in the J&K Excise and State Taxes (Subordinate) Service with immediate effect with the directions to report to **State Taxes Department, J&K** within a period of twenty one (21) days from the date of issuance of this order:

8. The appointment of the above said candidate shall be subject to fulfilment of the following conditions:-

A) The appointment including pay, service etc shall be governed in terms of J&K Special Recruitment Rules, 2015 [SRO-202 dated 30-06-2015].

B) The appointee shall be allowed to join only on production of the following certificates in original:-

1. Academic/Technical Qualification Certificates.
2. Matriculation/Date of Birth Certificate.
3. Health Certificate issued by Chief Medical Officer.
4. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
5. Permanent Resident Certificate.
6. Reserved Category Certificate/disability certificate (in case of candidates belonging to reserved category).

C) The appointment of the candidate as Sub-Inspector shall further be subject to the following conditions:-

- i. The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his appointment as Sub Inspector and his appointment as such shall be deemed to have been cancelled ab-initio.
- ii. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.

- iii. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of (i) and (ii) above are received in his favour.
- iv. The appointee shall be on probation for a period of 05 years and shall undergo and qualify the Departmental Examination (Excise and Taxation Part-1 Examination) within the period of probation.
- v. The inter-se-seniority of the appointee shall be strictly as per his merit in the select list.


