**Subject:- Payment of Dearness Allowance to Government employees continuing to draw their pay as per 6<sup>th</sup> CPC-revised rate effective from 01.07.2019.**

**Government Order No. 496 -F of 2019  
Dated 27 - 12 - 2019**

In continuation to Government Order No. 388-F of 2019 dated 10-07-2019, it is hereby ordered that Government employees continuing to draw their Pay as per 6<sup>th</sup> CPC, shall be paid Dearness Allowance as under:-

Existing Rate of DA	Revised Rate of DA	W.e.f.
154% of Basic Pay	164% of Basic Pay	01.07.2019

- i) The arrears on account of additional instalment of DA from July, 2019 to November, 2019 shall be paid in cash in December, 2019 and shall form part of the monthly salary from December, 2019 onwards.
- ii) The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.
