- d) Permanent Resident Certificate issued by the Competent Authority.
- e) Certificate from the concerned authorities to the effect that no loan under selfemployment scheme has been taken by the appointee concerned.
- f) Migrant Registration Certificate.

The appointment of the above candidates shall further be subject to the following condition that:-

- Each appointee shall execute an agreement in the "form" prescribed under Jammu and Kashmir Migrant (Special Drive) Recruitment Rules, 2009, issued under notification SRO 412 of 2009 dated 30-12-2009
- 2. Each appointee shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his/her academic/technical/category certificates where ever applicable and also character and antecedents is received from concerned issuing agencies /Inspector General of Police. (CID) to whom a reference shall be made by the concerned within whose jurisdiction he/she is posted, he/she shall have no right to claim his/her appointment as Junior Assistant as such shall be deemed to have been cancelled ab-initio.
  - 3. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
  - 4. The salary of these appointees shall not be drawn and disbursed to them until and unless satisfactory report about their character and antecedents and genuineness of their academic/technical/registration certificates is received from the concerned quartrs.
    - 5. The appointees shall be on probation for a period of 02 years.

- 7. Their inter-se-seniority of the appointees shall be in the order of a merit of the J&K Service Selection Board.
