Government Order No. 30 -F of 2020 Dated 24 -01- 2020

The Central Government has implemented recommendations of the 7th Central Pay Commission regarding abolition of Family Planning Allowance to Central Government employees vide O.M F.No. 12(4)2016-EIII.A dated 7th July, 2017.

In the Union Territory of Jammu & Kashmir, the employees are also entitled to special incentive in the form of Personal Pay for undergoing sterilization operation. Need has been felt for reviewing continuance of this incentive in favour of employees of Union Territory of Jammu & Kashmir in light of recommendations of 7th Central Pay Commission. The issue has accordingly been examined and, it is hereby ordered that:

"The special incentive available to employees of Union Territory of Jammu & Kashmir in the form of Personal Pay for undergoing sterilization operation in terms of Government Instruction No. 5 below Article 74 of J&K Civil Service Regulations is hereby withdrawn with immediate effect. The relevant provisions of J&K Civil Service Regulations Volume-I shall stand amended accordingly."
