Sanction is hereby accorded to the temporary appointment of Mst. Ishrat W/o Late Bilal Ahmad Parray(Ex-Senior Assistant) R/o SDA Colony, Bemina Srinagar as Class-IV (Orderly) in the pay Level SL 1(14800-47100) in the State Taxes Department, in relaxation of the prescribed qualification in terms of Rule-7 of SRO 43 of 1994, subject to fulfilment of the following conditions:-

- a) The appointee shall report for duties to the State Taxes Department viz , Additional Commissioner Kashmir, within a period of 21 days from the date of issuance of this order.
- b) In case of failure of appointee to join within the stipulated period, her appointment shall be deemed to have been cancelled without any further notice.
- c) The appointee shall be allowed to join only on production of the following certificates in original:-
 - i. Age and Health Certificate.
 - ii. Permanent Resident Certificate.
 - iii. Dependent Certificate issue by the Assistant Commissioner Revenue.
 - iv. All other relevant documents as are required under SRO-43/1994.
 - v. No Loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
 - vi. Relevant category certificate, if any.
- d) The appointee shall be initially on probation for a period of 02 years.
- e) The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about her character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim her appointment

as Class-IV and her appointment, as such shall be deemed to have been cancelled ab-initio.

- f) If on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- g) The salary of the appointee shall not be drawn and disbursed to the appointee unless the satisfactory reports in respect of (e) and (f) above are received in her favour.
