Subject:-Replacement of Manual TE (Transfer Entry) Procedure by e-TE w.e.f 01.04.2021.

> Government Order No. 118 F-of 2021 Dated: 3) /03/2021

J&K Funds Organisation will implement e-transfer procedure for transfer of balances of subscribers w.e.f 01.04.2021. All transferable balances w.e.f 01.04.2021 shall be transferred electronically via Gen-Profit Application.

Pending transferable balances of the subscribers pertaining to the period prior to cut-off date i.e. 01-04-2021, shall be transferred as per the procedure in-voque within a period of 04 months for which DDOs shall submit all such cases within a period of two months to concerned fund unit. All pending transfers must be completed during this time and certificate to this effect shall be submitted by Fund offices on 01.08.2021.

The subscribers accounts in the previous fund offices shall be automatically closed and the transfer of balance shall be informed to the subscriber through auto SMS alert.

NIC J&K Civil Secretariat Jammu shall modify the Gen-Profit Application accordingly.
