

ANNEXURE - B

One Chief Pay & Accounts Officer at Central level (Hqrs.) shall be there and four Pay and Accounts Officers, two each at Jammu and Kashmir have been proposed for implementation of Pay & accounts System as per above flow chart. These Pay & Accounts officers likewise one Director/FA& CAO, four Accounts officers shall be deputed by the Finance Department till the posts are created with the following conditions:-

- a) Government shall release funds under grant in aid in favor of Managing Director (Central Account) to be operated by CPAO.
- b) Money shall be transferred to the Accounts of CPAO/ PAO from central account.
- c) Release of payment shall be through CPAO/PAOs with respect to the claims of payees after proper scrutiny of bills and thereby transfer of money with the approval of controlling officer (Managing Director) from central account.
- d) Delegation of financial powers within the limits to CPAO/PAO shall be given with the approval of Board of Directors.
- e) The Corporation shall demand funds and incur expenditure within the budgetary limit approved by the Board of Directors.
- f) The CPAO/PAOs shall remit all the revenue accrued immediately into the Govt. account and remittances shall be made instantly in terms of Rules in vogue.
- g) The Corporation shall complete Book of accounts within stipulated period.
