164% of Basic Pension/Family Pension	189% of Basic Pension/Family Pension	01.07.2021

- (i) The increase subsumes the additional installments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Allowance for the period from 01.01.2020 till 30.06.2021 shall remain at 164%.
- The payment of Dearness Allowance involving a fraction of 50 paisa and (ii) above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.
