The payment of Dearness Allowance involving a fraction of 50 paisa and (i) above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.

The arrears on account of additional installment of DA from July, 2021 to (ii) November, 2021 shall be paid in cash in December, 2021 and shall form part of the monthly pension/Family Pension from December, 2021 onwards.
