1. To study the outcome of various initiatives taken by the Government during the year and to suggest best practices to be adopted for preparation of Economic Survey 2020;
2. To analyse the feedback of development departments viz-a-viz: vision, objectives, inputs, outcomes and policies adopted to achieve the desired outcomes;
3. To devise criteria, indicators and framework for Economic Survey.
4. To draft design and edit the Economic Survey on the basis of data analysed;
5. To review periodically the status of preparation of Economic Survey and its finalization by March 2021;
6. The copy of the draft Economic Survey 2020 shall be discussed in the Expert committee.

The Co-chairman of the committee will convene the meetings as per requirements for accomplishment of the assignment within time lines.

The committee shall be assisted by the Directorate of Economics & Statistics, J&K and shall place the final draft before the Financial Commissioner, Finance for approval to publish the document.
