The appointees shall be allowed to join only on production/checking /verification of the following certificates in original.

- Academic Qualification Certificate.
- Matriculation / Date of Birth Certificate.
- Health Certificate issued by Chief Medical Officer.
- Permanent Resident Certificate issued by the Competent Authority.
- Certificate from the concerned authorities to the effect that no loan under self employment scheme has been taken by the appointee concerned.
- Certificate of belonging to the reserved category, wherever applicable.

The appointment of the above candidates shall further be subject to the following condition that:-

- Each appointee shall execute an agreement in the "form" prescribed under Jammu and Kashmir Migrant (Special Drive) Recruitment Rules, 2009, issued under notification SRO 412 of 2009 dated 30-12-2009
- Each appointee shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his/her Academic/Technical/Category (if any) Certificates wherever applicable and also character and antecedents is received from concerned issuing agencies/Additional Director General of Police, (CID) to whom a reference shall be made by the concerned within whose jurisdiction he/she is posted, he/she shall have no right to claim his/her appointment as Junior Assistant as such shall be deemed to have been cancelled ab-initio.
- If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- The salary of these appointees shall not be drawn and disbursed to them until and unless satisfactory report about their character and antecedents and genuineness of their academic/technical/registration certificates is received from the concerned quarters.
- The appointees shall be on probation for a period of 02 years.

6. The appointment of the candidates shall be governed by the "New Pension Scheme" as per SO 400 of 2009 dated 24-12-2009 and;
7. Their inter-se-seniority of the appointees shall be in the order of a merit of the J&K Service Selection Board.

The appointees shall report in respective offices shown against each within a period of 21 days from the date of issuance of appointment order. In case the appointees do not join within the stipulated period, their appointment shall be deemed to have been cancelled ab-initio without any further notice.
