In continuation to Government Order No. 497-F of 2019 dated 27-12-2019, it is hereby ordered that Government Pensioners/ family pensioners continuing to draw their pension/ family pension as per 6th CPC, shall be, paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
164% of Basic Pension/Family Pension	189% of Basic Pension/Family Pension	01.07.2021

- (i) The increase subsumes the additional installments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Allowance for the period from 01.01.2020 till 30.06.2021 shall remain at 164%.
- (ii) The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.
