**Subject:** Authorization of 50% District Capex (Regular Component) out of approved BE 2020-21 in respect of "New Works".

Government Order No. 31 - F of 2021  
Dated: 29 . 01 . 2021

Sanction is hereby accorded to the release of 50% funds under District Capex out of approved BE 2020-21 in respect of "New Works" subject to the condition that District Development Commissioners/Controlling Officers/Accounts Officers shall make further releases to the executing/spending agencies in respect of only such new works which have been identified for completion preferably during the current financial year 2020-21 or by next financial year 2021-22.

The work-wise/activity-wise releases shall be made through BEAMS and the District Development Commissioners shall review the progress of completion/expenditure on fortnightly basis. The main focus should be on outcome and each new work taken up for execution should be fully verified and should conform to the laid down procedures like Accord of Administrative Approval/Technical Sanction, e-tendering, furnishing of Geo-tagged photographs of projects etc.

The utilization of funds so released in respect of "New Works" shall further be subject to the conditions as already stipulated in respect of "Ongoing Work" and "Non-construction activities" vide Government Order No.03-F of 2021 dated:05.01.2021.




