In continuation to Government Order No 305-F of 2021 dated 17.11.2021, it is hereby ordered that Government Pensioners/Family Pensioners shall be paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
31% of Basic Pension/ Basic Family Pension	34% of Basic Pension/ Basic Family Pension	01.01.2022

- i. The arrears on account of additional installment of Dearness Allowance with effect from January, 2022 shall be paid in cash to Government Pensioners/Family pensioners in the month of April, 2022 and shall form part of pension /family pension from April, 2022 onwards.
- ii. The payment on account of Dearness Allowance involving fractions of 50 paisa and above shall be rounded to the next higher rupee and the fractions of less than 50 paisa shall be ignored.
- iii. Other provisions governing the grant of Dearness Allowance on pension/family pension such as the regulations of Dearness Allowance during employment /re-employment, where more than one pension is drawn etc. and other provisions of the existing

rules/orders (as are not in conflict with provisions of this order), shall continue to remain in force.
