The appointees shall report to the concerned Department within a period of twenty one (21) days from date of issuance of this order failing which they shall forego their right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:-

- Academic/Qualification Certificates. i.
- Matriculation/Date of Birth Certificate. ii.
- Health Certificate from the concerned Chief Medical Officer of the iii. District.
- Domicile Certificate issued by the Competent Authority. iv.
- Valid relevant Category Certificate, if any, applicable. V.

The appointment of the above candidates shall further be subject to the following conditions:

- a. The clearance received from the Criminal Investigation Department (CID), J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls), as available through online mode under the Electronic Employee Verification System (EVS). Any false information provided by the appointee, or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment ab-initio, without any further notice.
- That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) & District Employment and Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self- employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c. Appointees shall furnish an Undertaking in shape of an affidavit as per Annexure-"A" to this order.
- d. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final character and Antecedents report is received from the concerned Authorities/Agencies.
- The appointees shall be on probation for a period of two years.
- d. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- e. The inter-se-seniority of the appointees shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

- The appointment of the above appointees shall be cancelled ab-initio, if it is found that they possess higher qualification than the prescribed one at any stage and they shall also be liable for criminal prosecution under Law.
- The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of Law.
