In continuation to Government Order No. 221-F of 2023 dated 04.12.2023, it is hereby ordered that the following procedure shall be followed for fixing the Revised Pension/Family Pension of Judicial Officers ordered vide Government Order No. 221-F of 2023 dated 04-12-2023.

Revision of pension / family pension in respect of Judicial Officers, who have retired/ died in harness prior to 01.01.2016, the Revised pension/ family pension shall be fixed as under:-

a) Formulation-I

Treasury Officers and or/paying branches of J&K Bank where from the pensioners/family pensioners draw their pension/family pension shall fix the revised pension/family pension as per formulation –I.

b) Formulation-II

For revising the pension/family pension as per Formulation-II, the formal pension revision authorization shall be issued by the Accountant General (A&E).

The individual cases of the fixation of pension under Formulation-II will be furnished by the Head of the Office to the Accountant General (A&E) from

where the pensioner has retired/where the deceased has served last, as per the format forming <u>Annexure-A</u>.
