On the recommendation of the J&K Services Selection Board conveyed vide letter No. JKSSB-Scry/12/2024-06 dated 29.07.2024 read with letter no. JKSSB-Scry/12/2024-06 (E-7479108) dated 07.02.2025, and on the basis of the CID verification report received through Excise Commissioner, J&K, sanction is hereby accorded to the temporary appointment of below mentioned candidate as Sub-Inspector (Divisional Cadre Jammu) in J&K Excise and State Taxes (Subordinate) Service in the Pay Level-4 (25500-81100) notionally w.e.f 12-09-2024 subject to the conditions given below that:-

1. The appointee shall report to Excise Commissioner for further duties within a period of twenty one (21) days from the date of issuance of this order failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:-

- i. Academic/Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Valid relevant Category Certificate.

3. The appointment of the above candidate shall further be subject to the following conditions:-

- a) The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/ Date of Birth/ Reserved Category Certificates from the concerned issuing authorities is found fake/ forged, his appointment as Sub-Inspector in the J&K Excise and State Taxes (Subordinate) Service, Finance Department shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b) If the Candidate has taken loan for self-employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) & District Employment and Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government services. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/ Relevant Category Certificate is received from the concerned Authorities/Agency.
- d) The appointee shall be on probation for a period of two years.
- e) The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f) The inter-se-seniority of the appointee shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956
- g) The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
