Subject: Payment of Dearness Allowance to Pensioners/ Family Pensioners on revised rate effective from 01.07.2024.

Reference: Council of Ministers Decision No. 001/01/2025 dated 20.01.2025.

Government Order No. 29 -F of 2025
Dated: 27 /01/2025

In continuation to Government Order No.179-F of 2024 dated 21.05.2024, it is hereby ordered that Government Pensioners/Family Pensioners shall be paid Dearness Allowance as under:

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
50% of the Basic Pension/Basic Family Pension	53% of the Basic Pension/Basic Family Pension	01.07.2024

- i. The arrears on account of additional installment of Dearness Allowance with effect from July, 2024 to December, 2024 shall be paid in cash in February, 2025 and shall form part of the monthly Pension/Family Pension from January, 2025 onwards.
- ii. The payment on account of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.
- iii. Other provisions governing the grant of Dearness Allowance on pension/family pension such as the regulations of Dearness Allowance during employment/re-employment where more than one pension is drawn etc. and other provisions of the existing rules/orders (as are not in conflict with provisions of this Order), shall continue to remain in force.
