In continuation to the Government Order No. 329-F OF 2024 dated 16.10.2024, it is hereby ordered that Government Employees continuing to draw their pay in the pre-revised Pay scale/Grade pay as per 6th Pay Commission, shall be paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
239% of Basic Pay	246% of Basic Pay	01.07.2024

- (i) The arrears on account of additional installment of DA from July, 2024 to February 2025, shall be paid in cash in the month of March, 2025 and shall form part of the monthly salary from March, 2025 onwards.
- (ii) The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored."
