PREFACE TO 7TH ANNUAL COMPENDIUM FOR 1998

SRO-7.—In exercise of the powers conferred by section 118 of the Constitution of Jammu and Kashmir the Governor is pleased to direct that the following amendments shall be made in J&K Financial Code Vol. II, namely :—

In the said Code :—

the following shall be inserted as: Rule 20 of Appendix 6.

- (20) The Deputy Director General NCC J&K shall be competent to purchase five (5) sets of Mufti Dress (as detailed below) on year to year basis for providing the same to Junior Commissioned Officers/Non-Commissioned Officers who will be taking part in the Republic Day Parade and Prime Minister's Rally at New Delhi. The cost of dress should not exceed Rs. 1,700/- each.

Details of Mufti Dress

- (a) Shirt Terricot/Woollen.
- (b) Twerd/Blazer Coat.
- (c) Trousers Terricot/Woollen.
- (d) Shoes one pair and socks.
- (e) Neck tie of appropriate design.

Subject :— Rationalisation of Pension Structure for pre-01-01-1996 Pensioners/Family Pensioners

Reference:— Cabinet Decision No. 291/29 dated 10-12-1997 read with order of Hon'ble Chief Minister dated 18-01-1998.

Government Order No. 46-F of 1998
Dated Jammu, the 19th Jan., 1998

1. It is hereby ordered that these orders shall apply to all the Pensioners/ Family Pensioners who were drawing pension/family pension as on 01-01-1996.

2. In these orders :—

- (a) "Existing Pensioner" and "Existing Family Pensioners" will mean a pensioner who was drawing/entitled to pension/family pension on 31-12-1995.
- (b) "Existing pension" will mean the basic pension inclusive of commuted portion of pension, if any, due on 31-12-1995.
- (c) "Existing Family Pension" will mean basic family pension drawn on 31-12-1995.
- (d) "Existing dearness allowance" will mean DA due to pensioner/ family pensioner upto average CPI 1510 (sanctioned vide Government Order No. 175-F of 1996 dated 10-6-1996 January 1996 instalment Refer Annexure III).

3. The pension/family pension of existing pensioners i. e. pre 01-01-1996 pensioners/family pensioners will be consolidated w. e. f. 01-01-1996 by adding together :—

- (i) The existing pension/family pension.
- (ii) The existing DA upto CPI 1510 of basic pension/family pension as admissible (Refer Annexure III).
- (iii) Interim Relief I & II (Refer Annexure III).
- (iv) Fitment weightage @ 40% of the existing pension/family pension.

The amount so arrived at shall be regarded as consolidated pension/ family pension w. e. f. 01-01-1996. The upper ceiling of pension/ family pension shall be 50% and 30% respectively of the highest pay in the Government. (The highest pay in the Government is Rs. 22,400/- since January, 1996). Since the consolidated pension will be inclusive of commuted portion of pension, if any, the commuted portion shall be deducted from the said amount while making disbursement.

4. Some of the existing pensioners who retired between 31-3-1985 and 31-12-1985 are in receipt of 'personal pension'. The said 'personal pension' shall continue to be granted as a separate element and will not be merged into the pension as consolidated at para 3 above.

5. The consolidated pension/family pension arrived at as per para 3 above includes dearness allowance upto average CPI level 1510 (i. e. January 1996 instalment sanctioned vide Government Order No. 175-F of 1996 dated 10-06-1996), the dearness allowance shall be admissible thereon only beyond index average 1510 in accordance with the orders to be issued by the Government. The two instalments of DA sanctioned w. e. f. 01-07-1996 and 01-01-1997 shall be adjusted against revised DA becoming due on the consolidated pension/family pension.

6. The amount of Interim Relief (III instalment) sanctioned vide Government Order No. 298-F of 1996 dated 31-12-1996 shall be recovered from the arrears becoming due on consolidation of pension/family pension as in para 3 above and sanction of DA on consolidated pension/family pension.

7. Where the consolidated pension/family pension in terms of para 3 above works out to an amount less than Rs. 1275/- the same shall be stepped upto Rs. 1275/-. This will be regarded as pension/family pension w. e. f. 01-01-1996. In case of pensioners who are in receipt of more than one pension the floor ceiling of Rs. 1275/- will apply to the total of all pensions taken together.

8. The employed/re-employed pensioners/family pensioners are not getting DA on pension at present under the earlier orders. In their case the notional dearness allowance, IR I & II which would have been admissible to them but for their employment/re-employment will be taken into account for consolidation of their pension in terms of para 3 above, as if they were drawing the dearness allowance and Interim Relief I & II. Their pay will be refixed w.e.f. 01-01-1996 with reference to consolidated pension becoming admissible to them. Dearness allowance beyond 01-01-1996 will however not be admissible to them during the period of employment/ re-employment.

9. Family pension under the existing rules is allowed at the normal rates under rule 20 (ii) (a), 20 (ii) (aa), (ii) (aaa) and also at enhanced rates under rule 20 (b), 20 (bb) and 20 (bbb) of Family Pension Rules-Schedule XV of J & K CSRs. Where the family pension is drawn at the normal rates the same shall be consolidated in accordance with para 3 above. Where the consolidated family pension falls short of Rs. 1275/- it will be raised to Rs. 1275/-.

In cases where family pension is drawn at enhanced rates it will be consolidated both at enhanced rates as well as normal rates separately so that updated normal rate is applied from the date the family ceases to be eligible for enhanced rate. The floor ceiling of Rs. 1275/- per month will also be applied separately for both the rates.

Pre 1-4-1965 family pensioners drawing pension under Rule 11-B of Family Pension Rules will also be covered under these orders. Where the family pension has been allowed in relaxation of rules, it will also be covered under these rules.

10. In the case of existing pensioners in whose case family pension has not come into operation as pensioner are/were alive on 01-01-1996, the rate of family pension at the enhanced rate and at normal rate noted on their PPO will be updated and consolidated by the Pension Disbursing Authorities. The updated rates of family pension will apply as and when family pension become payable in such cases.

11. In case of State Government employees who have been permanently absorbed in public sector undertakings/autonomous bodies and who continue to draw pension separately from the Government, their pension will be updated in terms of these orders. In cases where the Government servant have drawn one time lump-sum terminal benefit equal to 100% of their pension, their cases will not be covered under these rules.

12. A table indicating the existing pension, the consolidated pension and difference if any payable is given in Annexure I to this order. This table may be used where the pensioner is in receipt of a single pension only. Where a pensioner is in receipt of more than one pension, the consolidation may be done separately in terms of para 3 above and as indicated in para 7 above floor ceiling of Rs. 1275/- may be applied to total pension from all sources taken together. A suitable entry regarding the revised consolidated pension shall be recorded by the Pension Disbursing Authority (PDA) in both halves of PPOs. An intimation regarding disbursement of revised pension shall be sent to the Accountant General by the P. D. A. who had issued the PPO in the form given at Annexure II so that the Accountant General can update the PPO register maintained by him.

13. The consolidated pension/family pension as worked out in accordance with the provisions of para 3 above shall be treated as final 'Basic Pension'

w. e. f. 01-01-1996 and shall qualify for grant of dearness allowance sanctioned thereafter in respect of following categories of pensioners/family pensioners :-

- (i) Pensioners, who retired between the period from 1-4-1987 to 31-12-1995.
- (ii) Family Pensioners, who became entitled for family pension during the period from 1-4-1987 to 31-12-1995 and were sanctioned family pension @ 30% of the last basic pay drawn by the deceased employees.

14. In case of other pensioners/family pensioners, these orders provide for revision/consolidation of pension w. e. f. 01-01-1996 as an interim measure only so as to provide immediate relief and shall be subject to variation. Detailed instructions regarding fixation of their pay on notional basis revision/consolidation of pension/family pension and issue of authorisation in this regard will be issued separately. Pending issue of detailed instructions as stated above, grant of pension/family pension to all these pensioners/family pensioners may be continued to be regulated under these orders.

15. The arrears on account of consolidated pension would be paid in cash with the stipulation that where the arrears is less than Rs. 5000/- it should be paid in one instalment and where it exceeds Rs. 5000/- it should be paid in two instalments, in the first instalment, payment should be restricted to Rs. 5000/- plus fifty percent of their balance amount of arrears. Orders regarding payment of 2nd instalment will be issued separately.

16. The Treasury Officers and/or the Paying Branches of J&K Bank wherefrom the State Pensioners draw their pension shall pay pension/family pension at the revised rates without waiting for any further authorisation either from the Accountant General or from the General Manager J&K Bank. Where the Bank feels any doubt in revising pension/family pension in any case they should refer the matter to the concerned Treasury Officer for clarification. In the event of any doubt being felt by the concerned Treasury Officer, the matter shall be referred to Finance Department for clarification.

Table showing existing pension/family pension and the consolidated pension/family pension from 01-01-1996 and calculation of arrears from time to time.

Note : 1. Every care has been taken in preparing the Ready Reckoner. However, Pension Disbursing Authorities are personally responsible to verify the correctness of the amounts of consolidated pension and calculation of arrears shown against each item in this Ready Reckoner with reference to the provisions of the above Govt. Order before making payment.
