Government Order No. 10-F of 2009

Dated 08-01-2010.

In continuation of Government Order No. 187-F of 2009 dated 31-08-2009, it is hereby ordered that all the Government servants including Work Charged and Whole Time Contingent paid employees working in regular pay bands/scale shall be paid Dearness Allowance as under :—

| Existing Rate of DA | Revised Rate of DA | Date from which applicable |
|---------------------|--------------------|----------------------------|
| 22% | 27% | 01-07-2009 |

2. The differential amount payable on account of revised Dearness Allowance w. e. f. 01-07-2009 to 31-3-2010 to the State Government employees shall be credited to their individual GPF Accounts.
3. The basic pay for the purpose of this order shall mean the basic pay as defined in Note below Article 27(aa) of J&K Civil Service Regulations plus stagnation personal pay which has been allowed to be treated as part of the pay for Dearness Allowance as per Government Order No. 226-GR/F of 1990 dated 31-10-1990.
4. The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.

5. The provisions of this order shall also apply, *mutatis-mutandis*, in the case of All India Service Officers serving in connection with affairs of the State.
