Jammu/Kashmir, the 27th March, 2025

S.O. 75; In exercise of the powers conferred by clause (a) of Section 9 of the Stamp Act, 1977 (XL of 1977) the Government being satisfied that it is necessary to do so in the public interest hereby remit the Stamp Duty in respect of transfer of property by virtue of Gift Deed, within Blood relations, subject to production of any of the two documents mentioned in Annexure-A, to this notification in respect of both transferor and transferee.

For the purpose of this notification the Blood Relations means and shall include:- "Father, Mother, Brother, Sister, Son, Daughter, Grand Father, Grand Mother, Grand Son and Grand Daughter".

This notification shall come into force w.e.f. 1st Day of April, 2025.
