S.O 40 - In the Excise Policy 2020-21, notified vide S.O 275 dated 31st August 2020, the Lieutenant Governor is pleased to make the following amendments; namely:-

1. In Clause 13, in proviso thereto, the sign full stop (.) at the end shall be substituted by sign colon (:) and thereafter, the following proviso shall be added; namely:

"Provided further that due to closure of business activity on account of Covid-19 induced lockdown, the license holders of licenses namely, JKEL-2 (only for first slab of fixed License Fee of Rs 2.00 lacs), JKEL-3 and JKEL-4 shall pay the license fee on pro-rata basis."

2. For Clause 17, the following clauses shall be substituted; namely:-

" 17. Bottling fee

3. For Clause 18, the following clause shall be substituted; namely:-
"18. Tax and Duties on CSD: Excise Duty and Import Duty on CSD/PMFs shall be 25% less than that on Civil for all types of liquor."
