SRO 354. In exercise of the powers conferred by proviso to section 124 of the Constitution of Jammu and Kashmir, the Governor is pleased to direct that following amendments shall be made in Jammu and Kashmir Family Pension-cum-Gratuity Rules, 1964 as contained in Schedule XV of Jammu and Kashmir Civil Services Regulations Vol (II); namely:-

"In rule 22.-

In sub-rule (a);

- I. after clause (iv), the following clause shall be added, namely:-
 - "(v) failing (i) to (iv) to the divorced daughter."
- II. after Note 2, following Note shall be added, namely:-

"Note 3.- Subject to fulfillment of other conditions as laid down under these rules, the widowed/divorced daughter of a Government servant/pensioner will be eligible for family pension with effect from the date of issuance of respective orders, irrespective of the date of death of the Government servant/pensioner. Family pension of unmarried/widowed/ divorced daughter and dependent parents shall be payable only after the other eligible family members have ceased to be eligible to receive family pension and there is no disabled child to receive the family pension. Grant of family pension to children in respective categories shall be payable in order of their date of birth and younger of them will not be eligible for family pension unless the next above him/her has become ineligible for grant of family pension.

The dependency criteria for the purpose of family pension shall be the minimum family pension i.e Rs. 3500 p.m alongwith dearness relief thereon."
