SRO 376 .- In exercise of the powers conferred by sub-section (2) of section 3 of the Jammu and Kashmir Entry Tax on Goods Act, 2000, (Act No. IV of 2000), the Government hereby exempt from payment of entry tax, leviable under the said Act, the used goods shown in Annexure to this notification, to be imported into the State by the JK Developmental Action Group(NGO) as donation free of cost from Hamburg Germany for charity purpose subject to the condition that the Director Social Welfare, Kashmir/Jammu certifies that the goods so imported are exclusively meant for the aforesaid use only.
