SRO 75 . — In exercise of the powers conferred by the proviso to section 124 of the constitution of Jammu & Kashmir, the Governor is pleased to direct that the following amendment shall be made in the Jammu and Kashmir Civil Service Regulations, 1956, Vol-(II), namely:-

In schedule XI of the Jammu and Kashmir Civil Service Regulations, for the Explanation under Rule 10-B, the following Explanation shall be substituted, namely;-

"The apprentices appointed against post of Accounts Assistants after completion of the theoretical and practical training prescribed in these rules will be allowed the minimum of the Pay Band + Grade pay applicable to the post of Accounts Assistants with annual increment as per normal-rules. However, they will not be eligible to draw their sixth increment unless they qualify ACC Examination. The date of earning of sixth increment shall be reckoned from the date of passing of the said examination. The Accounts Assistant shall be encadred in Kashmir Subordinate Accounts service only after qualifying the prescribed examination.

Provided that the Account Assistants who fail to qualify the said examination, and have rendered 20 years service or more shall draw sixth annual increment and onward increments after crossing 50 years of age from Ist July of succeeding calendar year(s). However, the increments for intervening period withheld/not released for failure to pass the prescribed examination shall not be paid."
