SRO /39 :- In the exercise of the powers conferred by section 118 of the constitution of Jammu and Kashmir, the Governor is pleased to direct that in the Jammu and Kashmir Financial Code Vol-I below instruction 10 of rule 8.5; the following amendments shall be made namely:

- (i) The existing exception shall be renumbered as an exception No.1;
- (ii) The following shall be inserted as an exception No. 2;

"Exception: The Jammu & Kashmir Projects Construction Corporation is exempted from furnishing of Earnest Money with tenders while participating in bidding/tendering process of works floated/advertised by any Government Department for works."
