Addendum to O.M No: A/31(97)-488 dated 07-01-2019

In the O.M No. A/31(97)-488 dated 07-01-2019, the following Note shall be added at the end of para 3:

Note: If a Government servant does not accept promotion to a higher post offered to him, he may make a written request to the appointing authority to that effect, who shall consider the request taking into consideration the relevant aspects, and where the reasons for such non-acceptance/refusal of promotion are found satisfactory enabling the promotion of next (Junior) employee in the select list, the application shall be admitted. Under such circumstances, the employee shall not be considered again for such promotion for a period of six months or till recommendations of next DPC, whichever is later, from the date of such non-acceptance/refusal, besides such Government servant shall also lose seniority by such period vis-a-vis his erstwhile juniors promoted to the higher grade, whether by selection or otherwise, form the date of his refusal of promotion.

This shall be deemed existing ab-initio.
