SRO-22 :- In exercise of the powers conferred by proviso to section 18 of the constitution of Jammu and Kashmir, the Governor is pleased to direct that the following amendments be made in the Jammu and Kashmir Financial Code Vol-I namely:

Exception 5-A under Rule 14.4 below note 1 shall be substituted by the following:

"The Ladakh Autonomous Hill Development Council (Leh & Kargil) shall be competent to make advance drawal upto ₹50.00 lakhs with the concurrence of Chief Controller of Finance concerned without making a reference to Finance department."
