Subject: Revised Scheme for constitution and administration of State Disaster Response Fund (SDRF).

Reference: Thirteenth Finance Commission Award.

Government Order No. 187 -F of 2010

Dated: 07 -06-2010

Pursuant to the acceptance of the recommendations of Thirteenth Finance Commission (Th FC) by Government of India, sanction is hereby accorded to the following:-

- a. Creation of State Disaster Response Fund (SDRF) in the Public Account under Major Head: 8121- General and Other Reserve Fund in the interest bearing section, and merger of Calamity Relief Fund (CRF) with the said Fund w. e. f. 01.04.2010.
 - b. Transfer to the said Fund such amounts as may be released by Government of India from time to time, share of the State Government as prescribed in this behalf under the SDRF Scheme recommended by the Th FC and the interest accrued thereon by debit to the relevant budgetary provisions.
 - c. Transfer of closing balance as on 31.03.2010 under Calamity Relief Fund as duly reconciled with Accountant General, J&K to the SDRF.
 - d. Continuation of current accounting practice of meeting the expenditure under MH: 2245-Relief on account of Natural Calamities.
2. The total size of the SDRF for the State for the period 2010-2015 will be of the order of Rs. 952.93 crore as per the following year-wise sharing pattern:
