





Subject: Authorization of 50% funds out of five months Budget Estimates (31st October, 2019 to 31st March, 2020).
Reference: Presidential Order No: S.O. 3938 (E), dated: 31st October, 2019 issued by Ministry of Home Affairs, Government of India.

Finance Department conveys authorization to the utilization of 50% funds out of five months Budget Estimates (31st October, 2019 to 31st March, 2020) under both Revenue and Capital components out of the Consolidated Fund of the Union Territory of the Jammu and Kashmir pending the sanction of such expenditure by the Parliament. The funds shall be utilized subject to the terms and conditions mentioned in the authorization conveyed through BEAMS with due fulfillment of all the codal formalities.
